nvestors have given green signal to the nation's new apparatus of tax regime, the historic goods and service tax (GST). The sweeping tax reform is aimed to give substantial edge to the economy while drawing big investment into the country. Assocham seeks review of GST rate on bio-fertilisers

INDUSTRY BODY ASSOCHAM on Wednesday asked the government to review 18% GST rate on select agriculture inputs like bio-fertilisers, bio-pesticides and organic manures so as to compress the use of chemical fertilisers. In a letter to finance minister Arun Jaitley, it said a higher GST on bio-fertilisers, organic manures will promote the use of chemical fertilisers and impact public health. "Higher GST in this segment will directly promote chemical usage, leading to increase in green house gas emissions, besides adversely impacting public health," the letter said. The GST rate imposed on these items directly contradicts efforts being made by Prime Minister Narendra Modi in promoting projects such as Swachh Bharat, Soil Health Card, Namami Gange and various organic missions, Assocham said.

बायो उर्वरकों और कीटनाशकों पर कम हो टैक्स : एसोचैम

उद्योग चैंबर एसोचैम ने बायो-फर्टिलाइजर, बायो-कीटनाशक और ब्रांडेड ऑर्गेनिक खाद पर जीएसटी रेट घटाने की मांग की है। इसका कहना है कि रासायनिक उर्वरकों का इस्तेमाल कम करने के लिए बायो-प्रोडक्ट पर टैक्स कम करना जरूरी है। चैंबर ने इस सिलसिले में वित्त मंत्री अरुण जेटली को पत्र लिखा है। इसके मुताबिक इन पर ज्यादा टैक्स से ग्रीन हाउस गैसों का उत्सर्जन बढ़ेगा। यह स्वास्थ्य के लिए भी नुकसानदायक है। चैंबर का कहना है कि जीएसटी से पहले बायो-कीटनाशकों और दूसरी चीजों पर ज्यादातर राज्यों में 5-6 फीसदी टैक्स था। ब्रांडेड ऑर्गेनिक खाद पर 5% और बायो-फर्टिलाइजर और कीटनाशकों पर 12% जीएसटी लगाया गया है।
