The Law Commission of India is constituted by the Department of Legal Affairs, Ministry of Law & Justice, Government of India with a definite term of reference to carry out research in the field of law. The Commission makes recommendations to the government in the form of reports. The Law Commission has submitted various reports on significant issues in relation to the reforms required in law such as Report No. 165 that led to the enactment of the Right of Children to Free and Compulsory Education Act, 2009; Report No. 186 that resulted in the enactment of the National Green Tribunal Act, 2010; Report No. 246 that suggested important amendments to the Arbitration and Conciliation Act 1996; and Report No. 253 that contributed to the introduction of the Commercial Courts Act, 2015. Presently, it is engaged in working on various important issues, such as the Uniform Civil Code, simultaneous elections, protection of trade secrets, etc. The Law Commission of India provides excellent, thought provoking, and vital review of the laws in India. The current 22nd Law Commission of India is headed by Hon'ble Mr. Justice Ritu Raj Awasthi, former Chief Justice of the High Court of Karnataka.

About Conference

The economic value of an intellectual property emanates from an innovation that is contingent upon capability of the entity that possesses and preserves the confidentiality of materials embodying the trade secrets in a rightful and sustainable manner under the law. The US Economic Espionage Act of 1996 delineates the term 'trade secret' and comprehensively covers all forms, types, mechanisms, and even information having economic value that may be at risk of theft, misappropriation, and claims. The gross impact of foreign economic espionage exposes much higher cross-border complexities and risks, unlike the impact of unfair and anti-competitive practices by a competitor in the local market or in a particular sector.

EU countries and the USA have promulgated laws to protect and provide for preventive measures, injunctions, and compensation for infringements of trade secrets and have introduced general measures to protect them through civil or commercial courts as well. Currently, businesses in India use their trade secrets within their limited means to exercise the clauses under a non-disclosure agreement or non-compete agreement with the parties. Furthermore, they implement a robust IT security infrastructure for controlling the accessibility of important trade secrets, which is always insufficient in the modern emerging digital landscape.

So far in India, protection against trade secrets and economic espionage is provided under the Civil Law, Criminal Law, and Information Technology Act, 2000, which is insufficient and requires a lot of clarity. An unauthorized and illegal exploitation of an unprotected trade secret, if it remains uncovered under the specific legislation, poses an international threat, a serious risk, and serious economic consequences. Thus, a codified law with a separate regulator and enforcement authority in lines of sectoral regulators such as Competition Commission of India would address the issue and protect the industries and economy at large.

In view of the above, amid subject-related ongoing international developments and in pursuance of a need for India to have futuristic legislation, **The Law Commission of India** and **ASSOCHAM** are organising First International Conference on *"Protection of Trade Secrets and Economic Espionage: Trends and Impediments under Law, Regulation, and Enforcement"* on March 6, 2024, in New Delhi.

The conference aims to invite national and international stakeholders to participate, delve into the high-level deliberations, and contribute to India's progress in developing a model of legislation that balances and protects the trade secrets-related rights of all, including trade and industry.


