Introduction

The Chemical industry play a crucial role in economic development of any country and helps in improving the quality of life by providing products used in critical to a wide range of end-use applications. With Asia's increasing contribution to the global chemical industry, India emerges as one of the focus destinations for chemical companies worldwide as it remains an attractive hub for opportunities for both domestic and multinational manufacturers. Speciality chemicals segment comprises a significant portion of India's chemical industry. The major segments of speciality chemicals are Paints & coatings, Agrochemicals, Dyes, Colorants, Flavors & Fragrances, resins & binders, solvents, textile, Home & Personal Care, leather chemicals etc.

With rising demand for value-added products by both domestic consumption and exports, the industry has experienced a significant increase from end-user segments such as the food industry, automobile industry, clothes and cosmetics, among other industries and expected to outstrip China, Japan and the rest of the world. That's why India is emerging as the preferred manufacturing destination for companies across the globe. Speciality chemicals has a significant share of more than 50 per cent of chemical exports among which active pharmaceutical ingredients (APIs) and dyes & pigments are continuing to dominate the sub-segments.

COVID-19 pandemic and subsequent lockdown though had disrupted the operations, but these factors also drove demand for a few specialties chemical related to sanitation and hygiene. The lockdown period also led to supply chain disruptions and with 'China plus one' strategy, has compelled manufacturers to shift their bases away from China, towards developing countries like India. Likewise, government initiatives, such as the Petroleum, chemicals and petrochemicals investment region (PCPIR) policy, extension of RoDTEP benefits to chemicals, production linked incentive (PLI) schemes, are providing necessary support to the domestic manufacturing and speciality chemicals industry.

As government is promoting Make in India which aim to emerge as a manufacturing hub for the world, there are likely to be a few challenges for the industry in the near term. Therefore, the government may also like to focus on aspects such as Import substitution, feedstock supplies, Free Trade Agreement (FTA), Safety and Environment Protection, research and development, capital investment etc.
