Introduction

Natural Gas has emerged as a cornerstone of India's energy pillars, playing a vital role in the country's transition towards cleaner and more sustainable sources of energy. Being a clean and versatile fuel, it acts as a crucial bridge to connect traditional fossil fuels with renewables, offering a lower-carbon alternative that is a step towards fulfilling India's long-term energy security and environment sustainability.

India's rapid economic growth, accelerating urbanization, and the surge in manufacturing and industrial activities under the 'Make in India' and AtmaNirbhar Bharat programs have positioned natural gas to play a significant role in Nation energy mix. The government has introduced series of policies and reforms, including the Hydrocarbon Vision 2025 and Natural Gas Pipeline Policy, aimed at fostering innovation and investment within the industry. Open access reforms and the deregulation of natural gas prices have been instrumental to luring private and foreign investments.

India's gas pipeline infrastructure has expanded considerably in recent decades, with over 24,945 Kms of working pipes. The National Gas Grid, with the objective of increasing inter-regional connectivity and the smooth transport of gas all over the nation along with the development of regional pipelines, is central to facilitating the increase in consumption of gas, especially in the power sector, industry, and transportation.

India imports liquefied natural gas (LNG) through key terminals including Dahej, Hazira, Kochi, Ennore, Mundra with a combined capacity of approximately 47.7 million tonnes Per Annum (MTPA). New terminals are in the pipeline, particularly along the east coast, to meet regional demand and supply, offering cleaner energy to the power, industrial, and transport sectors.

The government's initiative to expand City Gas Distribution (CGD) geographical areas have resulted in the fast-paced growth of piped natural gas (PNG) to household and compressed natural gas (CNG) for vehicles in urban and semi-urban towns. This rapid expansion is part of India's overall vision to bring the percentage of natural gas in its energy basket from 6% to 15% by 2030.

India's gas infrastructure is undergoing transformation that will be play a crucial role in shaping the country's energy future. However, realizing this vision requires a set of success factors, enablers and founding building blocks. Impact of United Tariffs on CGD & Gas Markets, Pipeline and LNG Terminal Bottlenecks, Development & Maintenance Challenges, Domestic Production & Import Dependency is a necessity to meet this vision. As India advances towards cleaner fuels, an integrated gas network will be critical in providing a secure and affordable source of energy and supporting gas-based economy but also contribute to more sustainable and resilient energy landscape.
