India's merchandise imports are estimated to grow by about 15.8 per cent to USD710 billion in this fiscal from USD613 billion in 2021-22, on account of surge in imports of crude oil, coal, diamonds, chemicals and electronics, as per the Global Trade Research Initiative (GTRI).
