Sagarmala project pipeline doubles

The Centre's Sagarmala plan for port-led development saw an addition of 735 projects, taking the total pipeline to 1,537 projects at a cost of INR 6.5 trillion, Minister of Ports, Shipping, and Waterways Sarbananda Sonowal said.

Designed and built to move passengers at 180 kmph, these trains are expected to reduce the travel time between Delhi and Meerut by 40 per cent.
