### Centre approves India-UAE MoU on industrial cooperation

The government has approved a proposal for signing a bilateral MoU between India and the UAE on cooperation in the field of industries and advanced technologies. The MoU envisages cooperation on a mutually beneficial basis in areas including strengthening the supply chain resilience of industries, renewable and energy efficiency, health and life sciences, and space systems.

### India's exports rose by 24.2% to USD 9.4 bln during 1-7 June 2022

The country's exports increased 24.2% to USD 9.4 billion during June 1-7 on account of healthy growth in sectors like engineering, gems and jewellery, and petroleum products.
