India and the UK pledged to further bolster trade, defence, and energy ties, with visiting British Prime Minister Boris Johnson pitching for wrapping up a proposed free trade agreement (FTA) by as early as Diwali.

The country, he said, produced 31.9 million tonne of steel in the period with a growth of 5.9 per cent.
