Centre extends validity of ECLGS till March 2023

The Centre has expanded the scope of the Emergency Credit Line Guarantee Scheme (ECLGS) by allowing contact-intensive sectors to avail up to 50 per cent of their credit outstanding and raising the per borrower cap for the civil aviation sector to INR 400 crore. The ECLGS scheme has been extended by one year until March 2023.

India and Australia have signed an Economic Co-operation and Trade Agreement (ECTA) with an eye on doubling bilateral trade to \$50 billion in five years and easing the movement of people, goods, and services across borders.

UP reclaims position as top vegetable producer, leaves West Bengal behind

Uttar Pradesh has reclaimed its position as the top producing State in vegetables relegating West Bengal to the second position after two years. As per the data available, vegetable production in Uttar Pradesh is estimated to reach 29.58 million tonnes in July 2021–June 2022. Contrary to this, the vegetable production in West Bengal is estimated to drop to 28.23 million tonnes in July 2021–June 2022.

India to continue to buy discounted Russian oil

Union Finance Minister Nirmala Sitharaman said that India had already started buying discounted crude oil from Russia and has received 3-4 days' worth of supply. "We have received quite a number of barrels. I would think about 3-4 days of supply. I would put my country's national interest and energy security first. If fuel is available at a discount, why shouldn't India buy it," Sitharaman said.

Indian Oil to raise POL capacity to 5,530 tmtpa

PSU major Indian Oil Corporation said it will invest nearly INR 840 crore in expanding its Petroleum, Oil, and Lubricant (POL) storage capacities, including setting up a greenfield facility, in the Northeast. The company is planning to take its POL capacities to 5,530 thousand metric tonnes per annum (TMTPA) by 2030 from the existing 3,160 TMTPA.



Transportation

Centre approves setting up of 21 greenfield airports

Minister of State in the Ministry of Civil Aviation V. K. Singh informed that the Indian government had given 'In Principle' approval to setting up twenty-one greenfield airports across the country. These airports would come up at Mopa in Goa; Navi Mumbai, Sindhudurg, and Shirdi in Maharashtra; Bijapur, Hassan, Kalaburagi, and Shimoga in Karnataka; Dabra in Madhya Pradesh; and Kushinagar and Jewar in Uttar Pradesh, among others.

The project will help create the largest industrial belt in the Delhi-Mumbai industrial corridor area by linking the industrial parks and harbors of these states between Delhi and Mumbai.
