On an average 1.6 million e-way bills were generated on daily basis, data for the week ended 13 June 2021 showed. This number was around 1.2 million during the week ended 16 May 2021.

Exports rise by 46.4% during 1-14 June 2021

Showing healthy signs of revival, India's exports grew by 46.4 to USD 14.1 billion during 1-14 June 2021 compared with a year earlier, according to the Ministry of Commerce & Industry's preliminary data.

The Delhi-Meerut regional rapid transit system (RRTS) corridor is set to get the facility of automatic fare collection (AFC) and quick response (QR) code-based ticketing for commuters. The information was shared by the National Capital Region Transport Corporation (NCRTC) on 18 June 2021.
