The National Institute of Public Finance and Policy (NIPFP) has revised India's real GDP growth projection for 2024-25 downwards to 6.9-7.1 per cent, compared to its April 2024 estimate of 7.1-7.4 per cent. This revision is due to slower growth in the June 2024 quarter.

This deal boosts Varroc's total contracted solar capacity with AMPIN to 60 MW in Maharashtra, reflecting their commitment to innovative renewable energy solutions.

The Asian Development Bank approved a USD 434.25 million loan to boost renewable energy in Assam. This project will help Assam develop solar energy capacity and achieve its 3,000 MW target by 2030. A grid-connected solar photovoltaic facility will be constructed in Karbi Anglong district with 500 MW capacity, along with a battery energy storage system.

Tata Power has acquired a 40 per cent stake in Bhutan-based Khorlochhu Hydro Power Limited for INR 830 crore. The acquisition was finalized with Druk Green Power Company to develop the hydro project, estimated to cost INR 6,900 crore.
