Floating solar power plant to come up in Gurugram, Haryana

Haryana is set to get its first floating solar power plant in Gurugram. The unit will come up at the Chandu Budhera water treatment plant, which has an area of around 8.9 hectares. If the project turns out to be successful, this would be north India's biggest floating solar power plant.

Gujarat CM lays foundation for state's 225th industrial estate

Currently under the scheme, farmers pay an installment of Rs.1000 for crop insurance and receive a insurance claim between Rs.400-450 in case of crop loss.
