According to the action plan approved by the Uttar Pradesh Power Corporation (UPPC), the five state-owned power discoms plan to bring down the Aggregate Technical & Commercial losses to 16.43 per cent by the year 2024-25 from 29.04 per cent in the year 2021-22.
