Haryana

Haryana govt plans to introduce third-party audit before giving OC to buildings

The Haryana government is planning to introduce an independent third-party audit before giving the occupation certificate to a building. The new system would be a mix of self-certification and government intervention, by which audits will be introduced to ensure compliance with regulations.

The Haryana government has decided to launch a policy for the resolution of stressed assets within the framework of the RERA Act and the Urban Areas Act. This would help in establishing a transparent and reliable mechanism for ensuring the structural stability of multi-storey buildings.

The Haryana government has imposed a ban on the plying of diesel auto-rickshaws older than 10 years and petrol ones older than 15 years in Gurugram. The state government has not taken any decision to remove old vehicles in other cities and is working on a plan to provide relief to people living in other districts falling within the NCR limits.

Himachal Pradesh govt registers 17% increase in GST revenue

The Himachal Pradesh government has recorded Goods & Service Tax (GST) collection of Rs. 3.2 billion in February 2022, as compared to Rs. 2.7 billion in the corresponding period in 2021. This translates to an overall growth of 17 per cent in the state's GST revenue.

Punjab

Punjab govt targets 23% increase in area under cotton

The Punjab government is targeting to increase area under cotton by 23 per cent in the upcoming kharif season starting from April 2022. Following this, the total land under the commodity will increase from 325,000 hectares in 2021 to 400,000 hectares this year.

DRDO allocates Rs. 12 bln for academic research in defence in Gujarat

Around 40 students have already registered for the courses and they will get an opportunity to work in the defence laboratory.

With this, there are 92 dialysis centres under the programme.

Maharashtra

Maharashtra's PMC approves infrastructure projects worth Rs. 25 bln

The Bhartiya Janata Party (BJP)-led Pune Municipal Corporation (PMC) in Maharashtra approved infrastructure projects worth Rs. 25 billion. Prime Minister (PM) will inaugurate multiple civic projects, including the Pune Metro rail, on 6 March 2022.

Maharashtra govt launches Agriculture Export Policy

The Maharashtra government launched the state's Agriculture Export Policy (AEP). The policy will focus on the export promotion of 21 agricultural commodities as it can help increase the net income of farmers by about 40 to 45 per cent, according to The Economic Times. Some of the activities envisaged under the policy are infrastructure creation, export of organic products, export of products registered under Geographical Indication, developing sea protocol & trial consignments, etc.

Goa government notifies charging infra policy for electric vehicles

The Goa state government has notified the Goa EV Concessional Charging Infrastructure Policy 2021. This will pave the way for EV charging stations across the state. It will also boost sales of electric vehicles. As per the policy, the charging stations operators shall be allowed other sources to generate revenue, but with prior approval.

Goa govt allows school students to attend offline classes without parental consent

The Goa government has withdrawn its circular making parents' consent mandatory for school students to attend physical classes. The move has come after parents raised objections to the consent forms. In another development, an expert committee has recommended to the state government that schools can begin functioning at full capacity, in view of the declining coronavirus (COVID-19) cases.



Madhya Pradesh

Madhya Pradesh To Set Up Agriculture Excellence Centers In Cooperation With Israel

The Consulate General of Israel Shri Kobbi Shoshani told Chief Minister Shri Chouhan that out of 29 centres of excellence in agriculture in India, Israel proposes to set up two centres in Madhya Pradesh. Officers of Madhya Pradesh's Agriculture and Horticulture Department will be benefitted through a fortnight's specialization course in Israel.

Tamil Nadu

Tamil Nadu tops country's overall renewable capacity

Tamil Nadu has topped the chart in overall installed renewable energy capacity across the country. The state's total capacity stood at 15,914 MW followed by Karnataka with 15,795 MW, as on 31 January 2022. The state's total solar capacity increased to 4,894 MW, including ground-mounted, rooftop and off-grid capacity, from 2,575 MW as of 31 March 2019.

The Tamil Nadu government has reduced the fee paid by foreign medical graduates to obtain no-objection certificates (NOC) to do their internships in government medical colleges. Following this, the fee has been slashed by more than 90 per cent, from Rs. 354,000 to Rs. 29,400.

Andhra Pradesh

Andhra Pradesh govt plans to develop air connectivity to Hope Island

The Andhra Pradesh government is planning to develop air connectivity between Kakinada and Hope Island in the Kakinada Bay. The move aims to facilitate people to explore the scenic beauty of the Godavari estuary in the state.

The Telangana government has decided to come up with chemotherapy and radiotherapy centres in each district of the state. The move aims to ensure convenience for thousands of cancer patients who travel to Hyderabad and other major hospitals for cancer treatment from far-flung areas.

The Delhi Metro Rail Corporation (DMRC) and Central Public Works Department (CPWD) have signed an MoU. As per the pact, the former will provide technical assistance and execute finishing & service works for the construction of a loop corridor connecting the existing Metro network with the new Central Secretariat buildings. Under the proposed plan, a Metro loop corridor of around three-km, will cater to those wishing to travel to these offices using the Metro.



Uttar Pradesh

AAI to provide air navigation services at Jewar airport

The Airports Authority of India (AAI) and Yamuna International Airport (YIAPL) has inked an agreement for the provision of Communication Navigation Surveillance Systems (CNS) & Air Traffic Management (ATM) facilities and services at the Noida International Airport or the Jewar airport. The Jewar airport is expected to be commissioned by the year 2025.

Uttar Pradesh govt to pay bonus to contractors for completing Purvanchal Expressway before time

The Uttar Pradesh government would pay Rs. 1.8 billion as bonus to contractors for completing the 341-km-long Purvanchal Expressway 150 days before the scheduled completion date. The project contract had a clause, according to which contractors would be paid a bonus equivalent to 0.04 per cent of the contract price for each day of early completion from the completion date, subject to maximum of per cent of contract price.

Rajasthan

Rajasthan CM approves Rs. 2 bln for renovating Ferozepur feeder canal

Rajasthan Chief Minister (CM) Ashok Gehlot has sanctioned an amount of Rs. 2 billion for the renovation of the Ferozepur feeder canal. The canal emanates from the Harike barrage and supplies water to Sriganganagar, as per The Tribune. The renovation is being undertaken as the lining of the structure has collapsed at several places and 4,800 to 5,300 cubic foot per second (cusecs) of water is being released, instead of the canal's original capacity to carry 6,000 cusecs.

The Rajasthan government has announced the 'Camel Protection and Development Policy', to tackle the problem of declining number of camels in the state. A budget of Rs. 100 million has been proposed in the next financial year under the new policy for rearing, protection and overall development of the state animal.

Rajasthan is set to get as many as two new solar parks with 1,800 MW capacity in Jaisalmer and Bikaner. Approval for the same has already been received from the Union ministry of new and renewable energy.



West Bengal

COVID-19-induced night curbs to continue in West Bengal till 15 March

The COVID-19-induced night curbs from midnight to 5 am will continue in West Bengal till 15 March 2022. The move has come in the wake of the declining cases of COVID-19. Barring essential & emergency services, movement of people, vehicles and all public gatherings will be prohibited during the said period.

Thirty countries attend interactive meeting before Bengal Global Business Summit

Thirty countries attended a special meeting organised by the West Bengal government, before the Bengal Global Business Summit (BGBS) takes place in April this year. The West Bengal government has been attempting to draw investors to the state. The BGBS, scheduled to take place on 20-21 August, has infrastructure, agri & allied activities, industries (including MSME), services including health and education, tourism, exports, IT & ITeS, and mining as its focus sectors.

Bihar SGDP growth rate expected to be 9.7% in 2022-23

The Odisha commerce & transport department is planning to make highways in the state 100 per cent road signage compliant. The objective is to prevent road mishap fatalities by improving road infrastructure to warn, inform, guide and delineate the commuters.
