Punjab

TDI Infratech to invest Rs.6 billion in Punjab over next 3 years

TDI Infratech will invest Rs.6 billion in Punjab over the next three years as a part of its expansion plans. An amount of Rs.1.5 billion will be spent on its project Parkstreet on PR-7, which will come at Sector 118 in TDI City, Mohali. Another Rs.2 billion will be invested in TDI's commercial project South Ex-II, which will have built-up SCOs and SCO plots.

The decision has been taken with an aim to facilitate and encourage the residents to pay municipal taxes, including property tax, general water tax, special water tax, light tax and sewerage tax, among others.

In addition, facilities like management of infectious diseases, diagnosis of non-infectious diseases and emergency medical services are also provided at these centres.





Maharashtra

Maharashtra govt to generate 12,000 MW of renewable energy in 6 years

The Maharashtra government has decided to set up 12,000 MW of new solar power generation plants over the next six years. The move will ensure that there is no shortfall in electricity supply due to growing demand for power, especially during summer.
