The roads, with a 377-km cumulative length, will help the central government in generating Rs. 180-200 billion as revenue, reported The Times of India.

It has inked pacts with the Indian Institute of Management, Ahmedabad and the Indian Institute of Technology, Gandhinagar for developing a climate change policy and a road map for net-zero emissions by 2070.



Maharashtra

PM unveils two additional railway lines between Maharashtra's Thane & Diva

Prime Minister (PM) Narendra Modi inaugurated two additional railway lines connecting Thane and Diva in Maharashtra. The cost of the project, which features a 1.4-km-long rail flyover, three major bridges, 21 minor bridges, has been pegged at Rs. 6.2 billion. These lines will significantly remove the interference of long-distance train traffic with suburban train traffic in Mumbai.

The country's first biosafety level-III containment mobile laboratory was launched in Maharashtra's Nashik. The laboratory would help in investigating newly-emerging and reemerging viral infections that are highly infectious and of lethal potential to human beings.

South Asia's largest bio-CNG plant unveiled in Madhya Pradesh's Indore

Prime Minister (PM) Narendra Modi unveiled South Asia's largest bio-CNG plant in Madhya Pradesh's Indore, today. The facility has been developed based on the concept of waste-to-wealth innovation under a public-private partnership (PPP) model. The estimated cost of the project has been pegged at Rs. 1.5 billion.

Telangana information technology (IT) & industries minister KT Rama Rao and state labour minister Malla Reddy have laid the foundation stone of the Gateway IT Park situated in Kandlakoya in Medchal-Malkajgiri district.

Bihar registers 2.5% rise in GSDP

Bihar registered a 2.5 per cent growth in its gross state domestic product (GSDP) in 2020-21. The state's GSDP at constant prices increased to Rs. 4.1 trillion in 2020-21, as against Rs. 4 trillion in 2019-20. The state economy is largely dominated by the tertiary sector with a 61.5 per cent contribution, followed by primary and secondary sectors with a share of 19 per cent and 19.5 per cent, respectively.

The Odisha government has decided to develop sports infrastructure worth over Rs. 3 billion in Bhubaneswar. These include an indoor athletics stadium, indoor aquatics stadium, tennis centre, staff accommodation and a high-performance centre (HPC) hockey building.
