## **Cabinet Decisions**

#### Cabinet approves Minimum Support Price for Copra for 2026 season

The Cabinet Committee on Economic Affairs, chaired by Prime Minister Shri Narendra Modi, has approved the Minimum Support Price (MSP) for copra for the 2026 season. In line with the Union Budget 2018-19 decision to fix MSPs at a minimum of 1.5 times the all-India weighted average cost of production, the MSP has been set at Rs. 12,027 per quintal for Fair Average Quality milling copra and Rs. 12,500 per quintal for ball copra.

The MSP for 2026 represents an increase of Rs. 445 per quintal for milling copra and Rs. 400 per quintal for ball copra over the previous season. Since 2014, MSPs have risen sharply—from Rs. 5,250 to Rs. 12,027 per quintal for milling copra and from Rs. 5,500 to Rs. 12,500 per quintal for ball copra—reflecting growth of 129 percent and 127 percent, respectively.

The higher MSP is expected to ensure better and more remunerative returns for coconut growers while encouraging expansion of copra production to meet rising domestic and global demand for coconutbased products. The National Agricultural Cooperative Marketing Federation of India (NAFED) and the National Cooperative Consumers' Federation (NCCF) will continue to serve as Central Nodal Agencies for copra procurement under the Price Support Scheme (PSS).

#### Cabinet approves CoalSETU window

The Cabinet Committee on Economic Affairs, chaired by Prime Minister Shri Narendra Modi, has approved the Policy for Auction of Coal Linkage for Seamless, Efficient and Transparent Utilisation (CoalSETU) by introducing a new "CoalSETU window" under the Non-Regulated Sector (NRS) Linkage Policy. This reform will allow coal linkages to be allocated through auctions on a long-term basis for any industrial use and for export, further strengthening ongoing coal sector reforms. Coking coal will not be offered under this window.

Under the new CoalSETU window, any domestic buyer requiring coal for industrial use can participate in the linkage auctions without end-use restrictions, aligning with the broader opening of the coal sector for commercial mining. Traders will not be permitted to participate. This policy builds on the existing NRS Linkage Policy of 2016, under which coal linkages were allocated to specified end-use sectors such as cement, steel, sponge iron and aluminium through auctions.

The existing auction mechanism for specified end-use sub-sectors under NRS will continue, and eligible end-users may also participate in the CoalSETU window. Coal obtained under this window may be used for own consumption, coal washing, or export, but not for domestic resale. Linkage holders will be allowed to export up to 50% of their allocated coal and may flexibly utilise coal across their group companies.

The policy aims to improve ease of doing business, ensure efficient utilisation of domestic coal reserves, reduce dependence on imports, and support growing demand for washed coal. By enabling washery operators and exporters to access coal linkages, the policy is expected to increase availability of washed coal domestically and enhance India's coal exports.



## **Cabinet Decisions**

#### Cabinet approves scheme of Conduct of Census of India 2027

The Union Cabinet, chaired by Prime Minister Shri Narendra Modi, has approved the conduct of the Census of India 2027 with a total outlay of Rs. 11,718.24 crore. The Census, the largest administrative and statistical exercise in the world, will be conducted in two phases—Houselisting and Housing Census from April to September 2026, and Population Enumeration in February 2027. For Ladakh and other snow-bound non-synchronous areas of Jammu & Kashmir, Himachal Pradesh and Uttarakhand, population enumeration will be conducted in September 2026.

About 30 lakh field functionaries will be deployed to carry out this nationwide exercise, visiting every household to collect data. Census 2027 will be India's first fully digital Census, with data collection through mobile applications and real-time monitoring via a dedicated Census Management & Monitoring System (CMMS) portal. Citizens will also be given the option of self-enumeration, and strong security features have been built in to safeguard data. Census data will be disseminated in a userfriendly manner, including through Census-as-a-Service (CaaS), enabling ministries to access clean, machine-readable and actionable datasets for policy making.

New technological initiatives include a Houselisting Block (HLB) Creator web map application for field planning and enhanced digital tools for supervision and monitoring. A comprehensive nationwide publicity campaign will ensure awareness, inclusive participation and last-mile engagement. As decided by the Cabinet Committee on Political Affairs in April 2025, caste enumeration will also be included in Census 2027 and captured digitally during the Population Enumeration phase.

The Census is expected to generate significant employment and capacity building. Around 18,600 technical personnel will be engaged for nearly 550 days, generating about 1.02 crore man-days of employment, while also building digital and data-handling skills at local, district and state levels. Census 2027 will be the 16th Census of India and the 8th since Independence, conducted under the Census Act, 1948 and Census Rules, 1990, and will continue to serve as the most comprehensive source of granular socio-economic and demographic data down to the village and ward level.



# **Industry Developments**

## Overall

#### Crisil pegs FY26 GDP growth at 7%

India's real GDP is projected to grow by seven per cent in 2025-26, up from 6.5 per cent in 2024-25, driven mainly by domestic consumption, Crisil Intelligence stated in its report. The agency flagged benign inflation, Goods and Services Tax rationalisation and income tax relief as key supports, even as United States tariffs pose risks to exports and investment.

#### Axis Bank projects India's GDP growth for 2026-27 at 7.5%

Axis Bank, in its Outlook 2026 research report, stated that India remains the fastest-growing large economy, with real GDP growth projected at 7.5 per cent in both 2025-26 and 2026-27. The report points to receding fiscal and monetary headwinds, slower fiscal consolidation and the lagged impact of monetary easing as key drivers of sustained above-trend growth.

#### **Engineering exports up 23.7% in Nov 2025**

Engineering goods exports rebounded sharply in November 2025, growing by 23.7 per cent year-on-year to about USD 11 billion despite tariff-related headwinds, according to industry body EEPC India. Exports had stood at USD 8.9 billion in the same month last year, following a steep decline in October.

## Rice exports remain flat at USD 7.3 bln during Apr-Nov 2025

Rice exports from India have remained flat at around USD 7.3 billion during April-November 2025 compared to USD 7.29 billion in the same period last year. This was due to higher global stocks and robust crop yield across major producing countries. Rice exports from India declined by 30 per cent to USD 0.8 bliion in November 2025 from USD 1.1 billion in the year-ago month.

#### Vegetable oil imports decline by 28% in Nov 2025

Vegetable oil imports to India declined by 28 per cent in November 2025 compared to the same period last year. This was because shipments of refined, bleached and deodrised (RBD) palm oil dropped to 3,500 tonnes, according to data from the Solvent Extractors Association of India (SEA).

## IndiGo cancels 113 flights across its network due to bad weather at Delhi airport

IndiGo cancelled 113 flights across its network due to disruptions caused by bad weather at Delhi airport on Tuesday, 16 December 2025. The Directorate General of Civil Aviation (DGCA) has announced 10 December 2025 to 10 February 2026 as the official fog window during this winter.

## Citroen India sees strong sales and export growth in December quarter

Citroen India experienced a significant rebound in the December quarter, with domestic sales rising threefold compared to the previous quarter and exports growing nearly 19 per cent, driven by strong demand from Africa and ASEAN markets. The growth follows the company's 'Citroen 2.0' strategy, which focuses on deepening localisation, expanding dealer networks, enhancing customer experience, and refreshing its model lineup with India-centric offerings.

#### No plan to phase out or retrofit vehicles not compatible with E20 fuel

India's Road Transport and Highways Minister clarified that vehicles not compliant with the new E20 ethanol-blended petrol standard will not be phased out or retrofitted. Studies indicate that normal engine wear from using E20 fuel can be managed through routine maintenance. Vehicle manufacturers are expected to clearly label models for fuel compatibility, helping consumers identify which vehicles can safely use the ethanol blend.

## **Banking and Financial Services**

#### RBI's dollar-rupee swap to inject USD 5 billion in banking system

The Reserve Bank of India's three-year dollar-rupee swap will absorb USD 5 billion from the market and inject an equivalent amount of rupees into the banking system to support liquidity and improve transmission of rate cuts, according to media reports. The auction is expected to be fully subscribed due to surplus dollar liquidity with banks.

## Healthcare

#### Mizoram sign loan deal with ADB to strengthen Health Care Scheme

The Mizoram govt. will soon sign a loan deal amounting to USD 108 million with the Asian Development Bank to implement the Mizoram Universal Health Care Scheme (MUHCS). Around 90 per cent of the loan amount will be repaid by the Centre, while the state government will repay 10 per cent within 15 years.

#### Reliance plans to introduce low-cost genomic testing

Reliance Industries is preparing to enter the genomic testing space with plans to sharply cut test prices to below Rs.1,000, positioning the move as a mass-access healthcare initiative. Through its subsidiary Strand Life Sciences, Reliance aims to scale genetic and cancer-screening diagnostics by lowering sequencing costs and expanding reach across income groups.

With passenger convenience in mind, the station has been equipped with lifts & escalators, modern waiting halls, improved lighting and upgraded sanitation facilities.

Stage-I construction is already underway in Lunglei district, with a projected cost of Rs.98.2 million.

#### Mid-size IT firms outpace large caps in market share gains

Indian mid-sized IT companies have recorded their fastest market share gains in the first half of the financial year 2025-26, as large-cap firms ceded ground, according to industry analysts. The combined market share of mid- and small-cap companies rose by 22 basis points year-on-year during the first half, while the top six India-based IT services firms collectively lost 40 basis points.

#### Prime Minister's state visit to Jordan

The visit resulted in the signing and renewal of several bilateral instruments aimed at strengthening cooperation across priority sectors. These include memoranda of understanding on technical collaboration in new and renewable energy, as well as on water resources management and development. A twinning agreement was concluded between Petra and Ellora to promote cultural linkages. The cultural exchange programme was renewed for the 2025-2029 period. In addition, a letter of intent was signed to cooperate on sharing population-scale digital solutions for digital transformation.

The visit marked the elevation of bilateral relations to the level of a Strategic Partnership. Key outcomes included agreements on cooperation and mutual administrative assistance in customs matters, and the establishment of a data centre at the Ministry of Foreign Affairs of Ethiopia. An implementing arrangement was concluded for cooperation in United Nations peacekeeping operations training. An MoU on debt restructuring under the G20 Common Framework was signed. Educational cooperation was strengthened through expanded scholarships, specialised short-term courses in artificial intelligence, and support to enhance maternal and neonatal healthcare capacity at a hospital in Addis Ababa.

It includes ambitious services commitments, enhanced mobility for professionals, and provisions for full foreign investment in key services. Cooperation was expanded to traditional medicine, pharmaceuticals, standards, and certification, including faster regulatory approvals and mutual recognition mechanisms. The agreement also allows for future negotiations on social security coverage for workers.



# International Developments

#### India and Argentina conclude ICAR-INTA work plan for 2025-27

India and Argentina signed a work plan for 2025-27 to strengthen cooperation in agricultural research, technology exchange, and capacity building. The framework focuses on sustainable agronomy, digital agriculture, biotechnology, and natural resource management. Priority areas include micro-irrigation, livestock improvement, crop biotechnology, and mechanisation. The work plan provides for germplasm exchange, expert interactions, joint research, and training in advanced agricultural technologies. Cooperation will also be deepened in oilseeds, pulses, and plant and animal health to support productivity and resilience in both countries.

#### India signs development loans exceeding \$2.2 billion with multilateral lender

India signed loan agreements worth over \$2.2 billion with the Asian Development Bank to support a range of development initiatives across states and sectors. The projects include upgrading industrial training institutes to strengthen skilling and employability, expanding affordable and inclusive rooftop solar systems, and augmenting tertiary healthcare capacity in Assam. Financing was also extended for the Chennai Metro Rail project and for integrated ecotourism and sustainable agri-based livelihood development in Meghalaya, aimed at improving connectivity, clean energy access, healthcare infrastructure, and income generation.
