Cabinet Decisions

Cabinet approves three new corridors as part of Delhi Metro's Phase V (A) Project

The Union Cabinet chaired by the Prime Minister, Shri Narendra Modi has approved three new corridors - 1. R.K Ashram Marg to Indraprastha (9.913 Kms), 2. Aerocity to IGD Airport T-1 (2.263 kms) 3. Tughlakabad to Kalindi Kunj (3.9 kms) as part of Delhi Metro's Phase - V(A) project consisting of 16.076 kms which will further enhance connectivity within the national capital. Total project cost of Delhi Metro's Phase - V(A) project is Rs.12014.91 crore, which will be sourced from Government of India, Government of Delhi, and international funding agencies.

The Central Vista corridor will provide connectivity to all the Kartavya Bhawans thereby providing door step connectivity to the office goers and visitors in this area. With this connectivity around 60,000 office goers and 2 lakh visitors will get benefitted on daily basis. These corridors will further reduce pollution and usage of fossil fuels enhancing ease of living. Details:

The RK Ashram Marg – Indraprastha section will be an extension of the Botanical Garden-R.K. Ashram Marg corridor. It will provide Metro connectivity to the Central Vista area, which is currently under redevelopment. The Aerocity – IGD Airport Terminal 1 and Tughlakabad – Kalindi Kunj sections will be an extension of the Aerocity-Tughlakabad corridor and will boost connectivity of the airport with the southern parts of the national capital in areas such as Tughlakabad, Saket, Kalindi Kunj etc. These extensions will comprise of 13 stations. Out of these 10 stations will be underground and 03 stations will

After completion, the corridor-1 namely R.K Ashram Marg to Indraprastha (9.913 Kms), will improve the connectivity of West, North and old Delhi with Central Delhi and the other two corridors namely Aerocity to IGD Airport T-1 (2.263 kms) and Tughlakabad to Kalindi Kunj (3.9 kms) corridors will connect south Delhi with the domestic Airport Terminal-1 via Saket, Chattarpur etc which will tremendously boost connectivity within National Capital.

These metro extensions of the Phase - V (A) project will expand the reach of Delhi Metro network in Central Delhi and Domestic Airport thereby further boosting the economy. These extensions of the Magenta Line and Golden Line will reduce congestion on the roads; thus, will help in reducing the pollution caused by motor vehicles.

The stations, which shall come up on the RK Ashram Marg - Indraprastha section are: R.K Ashram Marg, Shivaji Stadium, Central Secretariat, Kartavya Bhawan, India Gate, War Memorial - High Court, Baroda House, Bharat Mandapam, and Indraprastha.

The stations on the Tughlakabad - Kalindi Kunj section will be Sarita Vihar Depot, Madanpur Khadar, and Kalindi Kunj, while the Aerocity station will be connected further with the IGD T-1 station.

Construction of Phase-IV consisting of 111 km and 83 stations are underway, and as of today, about 80.43% of civil construction of Phase-IV (3 Priority) corridors has been completed. The Phase-IV (3 Priority) corridors are likely to be completed in stages by December 2026.

Today, the Delhi Metro caters to an average of 65 lakh passenger journeys per day. The maximum passenger journey recorded so far is 81.87 lakh on August 08, 2025. Delhi Metro has become the lifeline of the city by setting the epitome of excellence in the core parameters of MRTS, i.e. punctuality, reliability, and safety.

A total of 12 metro lines of about 395 km with 289 stations are being operated by DMRC in Delhi and NCR at present. Today, Delhi Metro has the largest Metro network in India and is also one of the largest Metros in the world.



Industry Developments

Overall

Output of eight core industries rises by 1.8% in November 2025

The index of eight core industries rose by 1.8 per cent on a year-on-year basis in November 2025. The index rose after falling by 0.1 per cent in October 2025. Electricity generation fell by 2.2 per cent, while output of coal, which is a key input for thermal power generation, increased by 2.1 per cent.

India to give duty-free access to 54.1% of New Zealand exports

India will give duty-free access to 54.1 per cent of New Zealand exports from day one of the implementation of the free trade agreement, according to media reports. It has given duty concessions on agricultural goods such as apples, kiwifruit, manuka honey and albumins (including milk albumin), however, with quotas and minimum import prices (MIP).

India excludes dairy sector from duty concessions with New Zealand

Rice exports from India have remained flat at around USD 7.3 billion during April-November 2025 compared to USD 7.29 billion in the same period last year. This was due to higher global stocks and robust crop yield across major producing countries. Rice exports from India declined by 30 per cent to USD 0.8 bliion in November 2025 from USD 1.1 billion in the year-ago month.

Rice stocks rise to record-high of 57.6 mt as of 1 Dec 2025

India's rice stocks have risen to a record-high of 57.6 million tonnes (mt) as of 1 December 2025. This is much higher compared to the government's target of 7.6 mt for 1 January 2026. Rising rice stocks are likely to allow India, world's largest rice exporter to boost exports, putting pressure on supplies from rivals like Thailand, Vietnam and Pakistan, according to media reports.

Pulses prices to remain stable in coming months

The prices of pulses are expected to remain stable in coming months. This would be due to adequate buffer, robust sowing and encouraging crop prospects. Currently, the government has nearly two million tonnes (mt) of buffer stock of pulses. Also, the sowing of rabi pulses, including gram, masoor (lentils) and urad increased by 14.5 per cent to 13.4 million hectares (mha) in the current season compared to the previous season.

The Food Safety and Standards Authority of India (FSSAI) has asked companies to stop using the word 'tea' for herbal and plant-based infusions that are not derived from the Camellia sinensis plant, citing consumer misbranding concerns.



Aviation

IndiGo can operate 5 leased B737 planes from Turkey only till March

IndiGo can operate five narrow body leased B737 planes from Turkey only till March 2026, according to the Directorate General of Civil Aviation (DGCA). The DGCA has further clarified that no further extension will be provided to the airline. The extension till March 2026 was provided as IndiGo still awaits the delivery of its A321-XLR long range aircraft.

An Air India spokesperson said that the airline has made changes to its North America schedule to better deploy capacity and manage rising costs linked to ongoing airspace restrictions. The decision is part of a wider adjustment to its international network, according to the airline.

Air India has decided to stop its non-stop flights to San Francisco from Bengaluru and Mumbai starting 1 March 2026. The decision is part of a wider adjustment to its international network. This decision has, however, caused confusion among passengers who have already booked tickets, especially for travel after 28 February 2025.

Delhi govt to roll out new EV policy from next financial year

The Delhi government has decided to roll out a new electric vehicle (EV) policy from the next financial year. Emphasis will be laid on subsidies, vehicle scrappage incentives and neighbourhood-level charging infrastructure. The move is aimed at curbing air pollution and accelerating the adoption of cleaner mobility in the national capital.

Car prices set to rise in 2026 due to cost pressures

Car prices in India are expected to increase in 2026 as auto manufacturers pass on rising costs to consumers. Higher commodity prices, a weaker rupee, and increased logistics expenses have led manufacturers to announce price hikes of up to around three per cent across various models. While competition may limit the extent of these increases, the adjustments reflect the industry's response to persistent inflation and currency pressures, marking the first round of price changes since the GST rate cut in September.

Kia opposes proposed fuel efficiency concession for small petrol cars

Kia India has written to the Prime Minister's Office (PMO) opposing a proposed concession under the upcoming CAFE-3 fuel efficiency norms that would benefit petrol cars weighing less than 909 kg. The company argues that the move would weaken the overall purpose of emission reduction, create an uneven playing field favouring one dominant player in the segment, and disrupt long-term product planning.



Banking and Financial Services

SBI Cards sees defaults declining

SBI Cards is witnessing a steady decline in defaults, according to Salila Pande, managing director. This decline is supported by improved repayment behaviour and lower delinquency rates. The bank's slippage ratio improved in the previous quarter, while gross non-performing assets fell to 2.85 per cent, dropping below three per cent for the first time in several quarters.

India is expected to have around 200 million credit cards by 2030, up from about 110-116 million at present, according to Salila Pande, managing director, SBI Cards. The overall credit card market is projected to grow at a compound annual growth rate of 20-21 per cent over this period.

Monetary policy stepped in to support growth by rate cut

The minutes of the monetary policy committee meeting held on 3 to 5 December 2025 stated there is a case for supporting growth through demand stimulus to preserve the growth momentum in H2 of 2025-26. From the fiscal side, the GST 2.0 reforms, the Rs 25,060 crores Export Promotion Mission to support diversification of markets, a Rs 20,000 credit guarantee scheme, and notification of the new labour codes, among other measures, have been announced to support economic growth, the minutes stated.

Coal's share in India's energy mix to shrink to 30-35% by 2047

The share of coal in the energy mix of India is expected to fall to 30-35 per cent by 2047, according to experts. Currently, the share of coal is at 70 per cent. The drop in share will reflect a long-term shift towards diversified energy sources.

ArcelorMittal has announced three renewable energy (RE) projects in India with a combined solar and wind capacity of one gigawatt (GW), according to media reports. These projects will involve an investment of about USD 900 million. The projects include 36 megawatts (MW) of solar capacity in Amaravati, a 400 MW solar project with 500 megawatt-hours (MWh) of battery energy storage in Bikaner.

Healthcare

Fortis to acquire TMI Healthcare for Rs.4.3 billion

Fortis Healthcare is set to acquire TMI Healthcare, which operates the People Tree Hospitals in Yeshwanthpur, Bengaluru, for Rs.4.3 billion. The deal includes the hospital, its infrastructure and the land on which it operates, along with an adjoining land parcel.

Puducherry admin to establish IT park

The Puducherry administration is taking efforts to establish an information technology (IT) park in the union territory (UT). The information was shared by Lieutenant Governor (LG) K Kailashnathan. The park will help in providing jobs to students passing out from colleges. Furthermore, the Centre has decided to fund the expansion of the airport, which will facilitate companies to invest in the UT.

Under the agreement, Bharat Biotech will take responsibility for large-scale production and supply of the vaccine across more than 70 highburden countries in Africa and Southeast Asia.

The product, approved earlier by the central drugs standard control organisation (CDSCO), will be exclusively marketed and distributed by Cipla and is designed to simplify insulin administration through an inhaler-based system.

Regional Developments

Andhra Pradesh

Andhra Pradesh CM sanctions projects worth Rs.13.5 bln

CM N Chandrababu Naidu sanctioned projects worth Rs.13.5 billion for the development of layouts in the Land Pooling Scheme (LPS)-8 zone. The authority also approved Rs.4.4 billion for setting up a flood pumping station, Rs.1 billion as additional funds for providing facilities in the residential quarters and nearly Rs.1 billion for establishing a Quantum Computing Research Centre in Amaravati.

Haryana Assembly passes 8 Bills

Madhya Pradesh

Madhya Pradesh Cabinet takes several decisions

On 22 December 2025, the Madhya Pradesh Cabinet gave administrative approval of over Rs.25 billion to upgrade the 62.7-km two-lane Badwah-Dhamnod road into a four-lane highway with paved shoulders. The sanctioned cost will cover land acquisition, upgradation and construction.

The police station has been established in view of factors such as an increase in population in the panchayat, incidents of crime & accidents and the presence of two arterial roads, including Avinashi Road and the Salem-Kochi highway.

International Developments

India-New Zealand Free Trade Agreement concludes with broad market access

India and New Zealand have concluded negotiations on a new-generation free trade agreement focused on tariffs, agricultural productivity, investment and talent. The agreement provides zero-duty access on 100% of India's exports, while India offers tariff liberalisation on 70% of lines covering 95% of bilateral trade. New Zealand extends its best-ever services offer across 118 sectors, boosts student mobility with uncapped post-study work visas, commits USD 20 billion in investment, establishes agricultural productivity partnerships with safeguards, excludes sensitive farm products, and allows duty-free inputs for Indian manufacturing.

India selected to chair Kimberley Process from January 2026

The Kimberley Process Plenary has chosen India to assume the chairpersonship from 1 January 2026, with India taking over as Vice Chair on 25 December 2025. The Kimberley Process is a tripartite initiative of governments, the diamond industry and civil society to prevent trade in conflict diamonds, as defined by UN resolutions. This marks India's third tenure as Chair. The Minister of Commerce and Industry noted that the decision reflects global confidence in India's commitment to transparent trade. India will focus on stronger governance, digital certification, traceability, data-led monitoring and responsible sourcing within the 60-member framework.
